State 4-H Ambassador Application Information Packet

For 30 years, outstanding 4-H members have been serving as State 4-H Ambassadors. Once again, the Oklahoma State 4-H Ambassador program is looking for self-motivated, enthusiastic youth leaders to promote the 4-H organization using the skills, knowledge and leadership abilities acquired in 4-H. Applications for State Ambassador are due March 15th.

Being chosen as a State 4-H Ambassador entails the acceptance of great responsibility and a total commitment to the Oklahoma State 4-H Ambassador program. We need individuals who are not afraid of people or work.

AMBASSADOR PROGRAM OBJECTIVES

- Make 4-H more visible in your county and across the state of Oklahoma
- Maintain relations with 4-H alumni and supporters
- Help 4-H members tell the 4-H story

ELIGIBILITY

Any youth currently active in Oklahoma 4-H who is 13 years of age or older by March 15th, 2025 and still has at least one year of high school remaining is eligible to apply. Once selected a State 4-H Ambassador, one may remain an Ambassador through the end of their 4-H career in accordance with the Oklahoma 4-H Rules and Guidelines, as long as the Ambassador meets the yearly responsibilities. (See Ambassador Guidelines)

EXPECTATIONS

The State 4-H Ambassador program is a time-intensive program and requires full participation to build relationships with team members, be in communication with 4-H donors and be prepared for State 4-H Ambassador events/activities.

Key expectations include:

- To uphold and abide by the Oklahoma 4-H Code of Conduct throughout the duration of their Ambassador career.
- To participate fully and meet State 4-H Ambassador Guidelines.
- To serve as a positive role model and representative of all Oklahoma 4-H members.
- To actively promote inclusion and respect for diversity within 4-H programs.
- To be responsible for providing or arranging personal transportation to all activities/events; Transportation to and from events/activities is not the responsibility of extension educators.
- To be prompt in response to emails and/or phone calls from advisors and fellow Ambassadors.
- If/and once selected, failure to meet the provided guidelines will jeopardize your opportunity to complete your State 4-H Ambassador term.

KEY ROLES & RESPONSIBILITIES

State 4-H Ambassadors serve in a variety of key roles throughout the year. The following are the minimum expectations of participation.

- Meet *all* Level 1, 2, & 3 Ambassador guidelines.
- The Ambassador Retreat and Leadership Team Retreat will be held the first full week of June. If a newly selected Ambassador cannot attend the retreat, they must forfeit their position.
- Travel when called upon to speak or provide support for the Oklahoma 4-H Program.
- Assume financial responsibility.
- Commit the time involved to reach objectives and participate in required activities/events.

May 3, 2025	Selection Day; Oklahoma State University Campus
June 3-5, 2025	Ambassador Retreat and Leadership Team Retreat; Stillwater

TRAINING AND RESOURCES

Oklahoma State 4-H Ambassadors are required to invest in a small portion of their uniform and Ambassador activities. Selected Ambassadors will be required to pay \$50 and payments will be due by June 1, 2025. Mrs. Mary Sue Sanders generously covers the rest of the uniform cost through an endowment.

Uniform includes:

- Green 4-H blazer
- Official name badge
- Ambassador necktie
- Ambassador crest
- Leadership team polo

Selected Ambassadors are also responsible for the following

- Transportation to/from all required events
- Ambassador Uniform
 - Navy pants with white button up shirt or
 - Navy sheath dress
 - Navy or brown close-toed shoes
- Communicating via email
- Registration for Leadership Team Retreat (approx. \$150) and State 4-H Roundup (approx.\$175.00)

APPLICATION PROCESS

Interested applicants will need to complete the following steps no later than **March 15th, 2025** at 11:59 p.m. central time.

1. Review all details in the Applicant Information Packet.
2. Complete the electronic State 4-H Ambassador Program Application.
3. Applicants will receive an email notifying them if they will advance on to Selection Day Saturday, May 3 2025.
4. Those advancing on to Selection Day will be chosen based on their application and reference letters.

Advancing applicants should be prepared to answer questions about the Oklahoma 4-H program and State 4-H Ambassador program.

- Interviewees will present a 3 minute extemporaneous speech on 4-H related topics.
- Interviewees should be prepared for a written correspondence assignment (thank you note, letter or invitation to a 4-H alum or donor).
- The number of applicants selected each year depends on the below factors:
 - Number of returning 4-H Ambassadors
 - Diverse representation of applicants and geographic area
 - A team of 24 State 4-H Ambassadors is our goal

CRITERIA FOR SELECTION

The Oklahoma 4-H Youth Development program is committed to ensuring that the State 4-H Ambassador Program is representative of the diversity of Oklahoma, is represented by youth who are exceptional in their leadership/service to their communities, members who can reason logically, act on their decisions and professionally represent the entire Oklahoma 4-H Youth Development Program. Final selection will be based on culmination of the following scores: application, references, interview, extemporaneous speech and writing assignment. A total of 9 judges will serve on the Ambassador Selection Committee.
